Sub: Application for Letter of permission for functioning of Devki Mahaveer Homocopathic Medical College & Research Hospital, Farathiya, Garhwa, Jharkhand 822114 with admission intake capacity of 50 seats for Undergraduate (BHMS) and for new PG Course MD (Hom) course 63 seats in the 7 subjects with 9 seats in Materia Medica, Homocopathic Pharmacy, Repertory, Practice of Medicine, Organon of Medicine, Paediatric and Psychiatry course regarding-

Sir.

Devki Mahaveer Homocopathic Medical College & Research Hospital, Farathiya, Garhwa, Jharkhand 822114 with admission intake capacity of 50 seats for Undergraduate (BHMS) course and for new PG Course MD (Hom) course 63 seats in the 7 subjects with 9 seats in Materia Medica, Homocopathic Pharmacy. Repertory, Practice of Medicine, Organon of Medicine, Paediatric and Psychiatry for the academic year 23-24. The College has submitted the Part 1 information in which the entire functional profile has been hartacted and new application for PG Course. MARB has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under NCH Act 2020, as per section 29 and subsection (3) of the Act.

As per the observations made by MARB, following information are provided for immediate rectification of the shortfalls. College shall fulfil all functional requirements as per the Minimum Standard Requirements as mentioned below:

- A. Teaching faculty: Total 32 fulltime faculty for UG are submitted in part -1. On examining deficiencies are found, which are below mentioned:
- There are no lower faculty available in Departments of Forence Medicine.
- Here are no Professor Réader available in Department of Community Medicine.
- There is no faculty available in department of Pathology and Microbiology.
- University approved guide list shall be submitted.

B. Hospital details:-

- Case records are not submitted against the direction issued from MARB. IPD and OPD case records
 (copy of one OP and one IP cases of Pⁿ and last day of every month) shall be submitted for
 verification.
- Case records should be maintained with demographic details of the patient such as name, age sex, address, phone number etc.
- Case sheets shall be maintained with complete case analysis and evaluation and repertorisation and
 made available in medical record room for academic purpose of students and for follow up
 attendance of the patients. All follow up attendance should be recorded on the case records.
- Lab investigation report should be maintained properly in case records.
- Disease diagnosis shall be recorded in all case records as per ICD 11 criteria.

All the shortfalls observed in your College shall be rectified within a period of 30 days or before counselling initiates, whichever earlier and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be cancelled without further notice.

According to the teaching faculty available for PG course, Medical Assessment and Rating Board has issued permission to start new post graduate course in Higher MD (Hom) course 26 seats in the 5 subjects with 05 seats in Materia Medica, 06 seats in Homocopathic Pharmacy, 06 seats in Organon of Medicine, 04 seats in Paediatrics, 05 seats in Psychiatry and did not Considered For PG In Repertory And Practice of Medicine due to lack of availability of teachers. Further MARB has considered the application for PG In 02 subjects Namely Repertory with 06 Seats and Practice of Medicine with 05 Seats.

Considering the above observations, and facilities available and submission of compliance against the Letter No- MARBH letter no 4-7/2022-23/NCH (MARBH) (12-01)/223-227 dated-06/07/2023. MARB has decided to issue Conditional Permission to Devki Mahaveer Homoeopathic Medical College & Research Hospital, Farathiya, Garhwa, Jharkhand 822114 with admission intake capacity of 50 seats for Undergraduate (BHMS) and 37 seats in 7 subjects with 05 seats in Materia Medica, 06 seats in Homoeopathic Pharmacy, 06 seats in Organon of Medicine, 04 seats in Paediatries, 05 seats in Psychiatry, 06 seats in Repertory and 05 seats in Practice of Medicine for Post Graduate course MD (Hom) for academic year 2023- 24.

All admissions shall be made from NPPT7AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State! UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by Medical Assessment and Rating Board.

Permission for Devki Mahaveer Homoeopathic Medical College & Research Hospital, Farathiya, Garhwa, Jharkhand 822114 for conducting UG (BHMS) course with 50 seats for the academic year 2022-23 regarding,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homocopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, as per NCH Act 2020 and its relevant regulations.

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homocopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls

1. Hospital staff:-

The college may provide duty rosters, attendance, acquittance of the teaching faculty and staff for last 3 months.

2. Teaching faculty:-

- Guest faculty:-The guest professors namely Dr. Rain Pravesh Prasad , Dr. Krishna Kant Dubey and Dr. Baleshwar singh have not submitted experience certificate. The same shall be submitted with the Compliance report.
- A. Part time: The College has provided 02 part time teachers against the requirement of 09. This shall be rectified and the list of part time teachers be submitted.

3. Miscellaneous:-

- Biometric attendance provided without in and out time.
- Form-16 are not from traces portal.
- Under payment of salaries and actual number of full time staff are only 9 (as per attendance on the day of hearing, non providing of time of " in and out")
- As per the documents submitted by the college, they have paid less than 9 Lakhs/months on salaries. (For teaching, Non-teaching and Hospital total 134 staff). The college shall submit the payment details of all teaching faculties and bank documents for the last 03

Though due to Covid situation IPD/OPD status are not considered for permission process this needs to be tremendously enhanced considering the status of the PG educational institute in Homocopathy. You are required to take necessary measures for improvement of OPD/IPD and the status of the same shall be apprised to MARBH within 3 months from the date of issue of this letter

After considering the provisions of NCH Act, 2020 and its relevant regulations Conditional Permission of the Medical Assessment and Rating Board is issued to Devki Mahaveer Homoeopathic Medical College & Research Hospital, Farathiya, Garhwa, Jharkhand 822114 for 50 Seats for UG 1st BHMS Course during the academic year 2022-2023.

All admissions in Under Graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under.

The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.

The college has to comply with the full requirements as per NCH Act, 2020 for conducting the course. All deficiencies observed, has to be rectified within 30 days' time from issue of this permission letter. Compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance.
